However, for purposes of a primary election, a United States citizen must be at least eighteen years of age as of the next general election following the primary election. In case of the death, resignation, or removal from office of the governor, the lieutenant governor shall become governor for the remainder of the term, which shall create a vacancy in the office of lieutenant governor.
